Please read this section carefully and review for accuracy.

- 1.All registration must be accompanied by a \$25 non-refundable registration fee and appropriate deposit or payment.
- 2.Upon registration 50% of tuition is due plus registration fee. Balance of tuition (payment in full) is due no later than June 1, 2016.
- 3.If written notice of cancellation is received prior to June 1, 2016 all payments will be returned less registration fee. After June 1, 2016, 50% of the fee will be returned.
4. If tuition paid in full on or before April 1, 2016, by check or cash a 10% discount may be applied to tuition.
5. If tuition paid in full by May 1, 2016, by check or cash a 5% discount may be applied to tuition.
6. Weekly tuition may not be prorated
7. A minimum enrollment of 6 students per session, per level is required to ensure continuance of the program. If this minimum is not met classes or sessions may be combined or canceled by June 1, 2016.
8. Faculty may be substituted due to professional conflicts.
